This amendment shall constitute the First Amendment to the following existing association document:

Bylaws of Hammock Trace Preserve Homeowners Association, Inc. as recorded in Book 5770, Page 6224, on April 19, 2007 in the Public Records of Brevard County, Florida.

This First Amendment was duly and properly adopted pursuant to the provisions of Article 9, Section 9.2 by the affirmative vote of at least two-thirds (2/3) of the total membership votes, as required with all due notice as required for a valid amendment.

Article 2.1

The Number of votes needed for a quorum on any vote in person or by certified written ballot of the Association shall be a minimum of thirty percent (30%) ten percent (10%) of the sum of all votes held by qualified Class A Members and Class B Members for any ballot to be valid. All matters to be voted on by the Association shall require quorum and shall be decided by a majority of those votes cast by Owners represented by the quorum unless a greater number of votes is required pursuant to these Bylaws, the Articles or the Declaration.

Article 9.2, Paragraph 2

At such meeting, if the Developer maintains a Class B membership, the Amendment or Amendments proposed must be approved by the Developer and an affirmative vote of members holding at least two-thirds (2/3) of the total membership votes (Class A and Class B combined for all phases of the Subdivision that will ultimately be operated by the Association), votes cast either by proxy or in person in order for such Amendment or Amendments of the By-Laws to be effective. [...].

Article 9.2, Paragraph 3

At such meeting, if the Developer no longer maintains a Class B membership, the Amendment or Amendments proposed must be approved solely by an affirmative vote of the members holding at least two-thirds (2/3) of the total membership votes <u>cast either by proxy or in person</u> and the above referenced procedure for certification, filing and recording shall be followed. [...]
