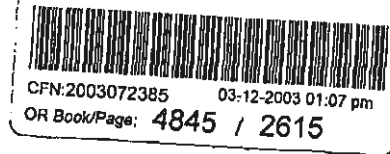

## CERTIFICATE OF AMENDMENT TO BYLAWS

OF

### 2100 WEST CONDOMINIUM ASSOCIATION, INC.

Pursuant to Section 718.112(1), Florida Statutes (2001), and the provisions of the Bylaws of 2100 WEST CONDOMINIUM ASSOCIATION, INC. ("the Association"), which Association is responsible for the management and operation of 2100 WEST, A CONDOMINIUM, according to the Declaration of Condominium thereof, as recorded in Official Record Book 2512, Page 0826, Public Records of Brevard County, Florida; and pursuant to the unanimous approval of the Board at the duly-noticed meeting thereof, which was held on February 10, 2003, pursuant to Article 12.2(c) of the Bylaws, the Bylaws are amended as follows:

1. Section 1 of the Bylaws is amended to read:

1. Identity. These are the By-Laws of ~~2100 WEST CONDOMINIUM ASSOCIATION, INC.~~ SUMMERWIND CONDOMINIUM OF COCOA BEACH, INC., (the "Association"), a corporation not for profit incorporated under the laws of the State of Florida, and organized for the purpose of administering that certain condominium located in Brevard County, Florida, and known as ~~2100 WEST SUMMERWIND, A CONDOMINIUM~~ (the "Condominium").

1.1 Principal Office. The principal office of the Association shall be at 2090 North Atlantic Avenue, Cocoa Beach, Florida 32931, or at such other place as may be subsequently designated by the Board of Directors. All books and records of the Association shall be kept at its principal office.

1.2 Fiscal Year. The fiscal year of the Association shall be the calendar year.

1.3 Seal. The seal of the Association shall bear the name of the corporation, the word "Florida", the words "Corporation Not for Profit", and the year of incorporation.

2. Wherever the name "2100 WEST, A CONDOMINIUM" appears in the Bylaws, the name "SUMMERWIND, A CONDOMINIUM" shall be substituted therefor.

IN WITNESS WHEREOF, the Association has caused this instrument to be signed in its name and by its President and Secretary this 12 day of February, 2003, for purposes of recording in the Brevard County Public Records as required by the Florida Condominium Act.

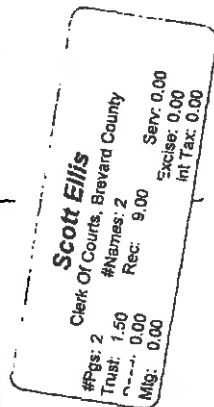

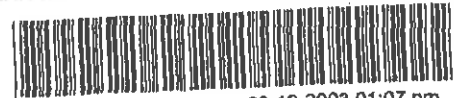

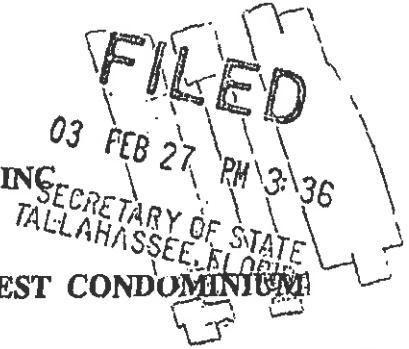

ARTICLES OF AMENDMENT  
OF  
2100 WEST CONDOMINIUM ASSOCIATION, INC.



1. Article I of the Articles of Incorporation of 2100 WEST CONDOMINIUM ASSOCIATION, INC., is hereby amended to read:

The name of the corporation shall be ~~2100 WEST CONDOMINIUM ASSOCIATION, INC.~~ SUMMERWIND CONDOMINIUM OF COCOA BEACH, INC. For convenience, the corporation shall be referred to in this instrument as the "Association", these Articles of Incorporation as the "Articles", and the By-Laws of the Association as the "By-Laws".

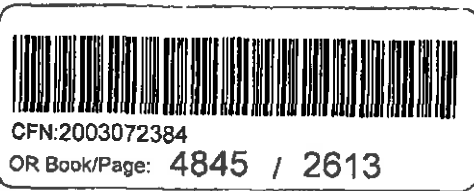
2. Article II of the Articles of Incorporation of 2100 WEST CONDOMINIUM ASSOCIATION, INC., is hereby amended to read:

4. This Amendment shall become effective upon the filing of the Articles of Amendment with the Secretary of State - State of Florida.
